My Human Rights Children's Rights Art Competition Guidelines

1. Introduction

The 'My Human Rights', Children's Rights' Art Competition, organised by MHREC aims to encourage individuals, particularly youth, to express their thoughts, emotions, and ideas regarding children's rights issues through various art forms. This document outlines the key terms and guidelines for the competition.

2. Artwork Submission

2.1. Eligibility Criteria

- Participants must not be older than 18 years old.
- Artwork submitted must be an original creation of the participant.

2.2. Artwork Medium

- Artwork can be created using various mediums, including paintings, drawings, digital art, or mixed media.

2.3. Artwork Size and Format

Entries that do not meet the eligibility criteria or violate the rules and guidelines of the competition may be disqualified at the discretion of the organisers.

8. Promotion and Communication

Participants are encouraged to promote the competition on their social media and other platforms. MHREC will also promote the competition through its official channels.
